ABOUT THE SHOW:

The **ATLANTA PASTEL EXHIBIT** attracts artists whose works are of the pastel medium. Show dates are **September 2 – September 28, 2010** at **The Gallery at Paper Mill Village**, 255 Village Parkway, Suite 320, Marietta, GA. 30067. A reception will be held on **Friday, September 10th** from **6:00 – 8:30 pm**.

ABOUT THE JUDGE:

Chin-Cheng Hung, born in Keelung, Taiwan in 1966, devoted his attention to the study of Chinese art since he was 12. In 1997, he came to the United States to pursue his MFA degree in painting at the Savannah College of Art and Design after a long career as a serviceman. Here, he also established his teaching career in the Foundation Studies since 1999. Hung is a signature member of the Pastel Society of America, member of the Southeastern Pastel Society, the Atlanta Chinese Art Association, the College Art Association, and member and former President of the Chinese American Academic and Professional Association in Southeastern United States. His biography was selected to be listed in the newest editions of Margus "Who's Who in the World", "Who's Who in America", "Who's Who in American Art", and "Who's Who among American Teachers and Educators". Hung has received numerous awards from different juried competitions and has been featured in "The Pastel Journal", "Pastel Artist International", "International Artist", and "New American Paintings" magazines. In September of 2004, he received Popular Vote Award in the 32nd Annual Exhibition for "Pastel Only" from the Pastel Society of America. His works hang in many private and corporate collections in Taiwan and the U.S.

ELIGIBLE ENTRIES:

This exhibition is open to works by pastel artists. No more than two (2) works from an artist will be accepted. There is no size restriction for this exhibit.

ACCEPTED WORK:

Artists will be notified by email or phone by **August 13, 2010**.

ART WORK PREPARATION, SIZE AND MAILING SPECIFICATIONS:

- All art work accepted must be properly framed and wired.
- All accepted works must have an identification card on the upper right hand corner on the rear of the painting.
- Ship via UPS or FED EX with paid return delivery paperwork and postage. No COD will be accepted. Please provide packing instructions, if necessary. Please do not include foam peanuts in packing materials.
- Work(s) may be sent via any transportation mode - hand delivered or shipped - to The Gallery at Paper Mill Village, 255 Village Parkway, Suite 320, Marietta, GA. 30067. Shipped works will be returned via UPS or FED EX. Accepted works need to arrive **no earlier than Friday, August 27th and no later than Saturday, August 28th**.

LIABILITY:

- All works submitted are the artist's own responsibility; any insurance must be arranged by the artist while works are in transit and for the duration of the show.
- All accepted art work will be handled with professional care; however, staff or volunteers cannot be responsible for any loss or damage.
- Damaged delivery boxes or crates will remain unopened pending notification of the carrier and artist.
- Work unclaimed by sender at return address on crate or box is not the responsibility of the sponsors of this show.

AGREEMENT AND COPYRIGHT:

Acceptance to this show is an agreement by the artist to all terms set forth in this "Call for Entries". Permission is granted to photograph and reproduce work for printed media, future show promotions, education and publicity.

AWARDS AND ART SALES:

Exceptional merit awards will be granted. Gallery receives 50% commission on sold work(s). No NSF works will be accepted in this exhibit.
