The **1st Annual Georgia Photography Show** attracts photographers from the state of Georgia. Show dates are **January 7 – 30, 2010** at **The Gallery at Paper Mill Village**, 255 Village Parkway, Suite 320, Marietta, GA. 30067. A reception will be held on **Friday, January 8th** from **6:00 – 8:30 pm**.

ABOUT THE JUDGE:

Corrine Adams, a recognized southeastern photographer whose works are in the permanent collections of the Museum of Contemporary Art of Georgia (MOCAGA), the Gregg Museum of Art in Raleigh, NC, the Atlanta Hartsfield-Jackson and Los Angeles International Airports, and hotels across the country including the Westin, Ritz-Carlton, Mandarin, Four Seasons, and Omni. She is included in the **Encyclopedia of Twentieth Century Photography** (2005, Routledge Press). Corinne is co-founder of **Atlanta Celebrates Photography**, an annual photography festival for the city of Atlanta. Her work has been reviewed by such media as Contemporary (international art journal), Art Papers, the Atlanta Journal Constitution, Chattanooga Times Free-Press, and the Savannah Morning News.

This exhibition is open to photographers within the state of Georgia.

ACCEPTED WORK:

Photographers will be notified by email or phone by **December 21, 2010**.

PHOTOGRAPHS:

All photographic works, including digitally enhanced photography, will be considered. All photographs must be properly framed and wired. No more than two (2) works from an artist will be accepted.

SIZE AND MAILING SPECIFICATIONS:

- There is no size restriction for this exhibit.
- All accepted works must have an identification card on the upper right hand corner on the rear of the painting.
- Ship via UPS or FED EX with paid return delivery paperwork and postage. Please provide packing instructions, if necessary.
- Works may be sent by any transportation mode - hand delivered or shipped - to The Gallery at Paper Mill Village, 255 Village Parkway, Suite 320, Marietta, GA. 30067. Shipped work will be returned via UPS or FED EX. Accepted work needs to arrive by **January 4th**.

LIABILITY:

- All works submitted are the photographer's own responsibility; any insurance must be arranged by the photographer while works are in transit and for the duration of the show.
- All accepted photography will be handled with professional care; however, staff or volunteers cannot be responsible for any loss or damage.
- Damaged delivery boxes or crates will remain unopened pending notification of the carrier and photographer.
- Work unclaimed by sender at return address on crate or box is not the responsibility of the sponsors of this show.

AGREEMENT AND COPYRIGHT:

Acceptance to this show is an agreement by the photographer to all terms set forth in this "Call for Entries". Permission is granted to photograph and reproduce work for printed media, future show promotions, education and publicity.

AWARDS and ART SALES:

Exceptional merit awards will be granted. Gallery receives 50% commission on sold work.

Accepted photography will be returned by **February 5, 2010**.
